## SECTION 2 — SCOPE OF SERVICES

Broker shall identify and introduce qualified aviation jet fuel suppliers, petroleum refineries, DLA Energy contractors, FBOs, and other relevant parties. Broker shall facilitate and arrange fuel supply transactions including pricing, volume, delivery logistics, and contract documentation, and provide any additional mutually agreed services.

**SECTION 3 — COMMISSION RATE AND PAYMENT**

Commission rate shall be agreed upon in writing prior to execution of any transaction. Commission is due within two (2) banking days of each transaction close via wire transfer or EFT to SAAFI EXPRESS LLC designated bank account. Commission applies to all transactions, renewals, extensions, and additional orders for five (5) years from first transaction date.

**SECTION 4 — IRREVOCABILITY OF COMMISSION**

The commission obligations set forth in this Agreement are IRREVOCABLE. Once earned, the Principal's obligation to pay cannot be revoked, cancelled, waived, or diminished for any reason whatsoever, including termination of this Agreement, dispute between parties, modification of underlying transaction, insolvency, bankruptcy, or change of ownership. This obligation survives termination of this Agreement indefinitely.

**SECTION 5 — NON-CIRCUMVENTION AND NON-BYPASS**

Principal irrevocably agrees not to contact, deal with, or engage — for any purpose — any party introduced by Broker without Broker's prior written consent and continued participation and compensation in all resulting transactions. ANY BREACH entitles SAAFI EXPRESS LLC to immediate liquidated damages equal to the GREATER of: (a) total commission on all circumvented transactions, or (b) \$50,000.00 USD. This is a genuine pre-estimate of loss and not a penalty.

**SECTION 6 — CONFIDENTIALITY**

Both Parties agree to hold in strict confidence all information disclosed in connection with this Agreement for five (5) years, including supplier/buyer identities, pricing, volumes, logistics, contract terms, banking details, government contract details, and trade secrets. Breach entitles the non-breaching party to seek injunctive relief in addition to monetary damages.

**SECTION 7 — GOVERNING LAW AND DISPUTE RESOLUTION**

This Agreement is governed by the laws of the State of Texas. Disputes shall proceed through: (1) good-faith negotiation within 15 days; (2) mediation in Harris County, TX within 30 days; (3) binding arbitration under AAA rules in Harris County, TX. Prevailing party recovers reasonable attorney fees and costs. The arbitrator's award is final and enforceable in any court of competent jurisdiction.
