1. IRREVOCABILITY

This Agreement is irrevocable, non-circumventable, and non-transferable. Buyer and Seller agree not to circumvent, avoid, or bypass the Broker to avoid payment of fees. Binding for all transactions, extensions, renewals, and additions for five (5) years from date of first transaction.

2. BROKER FEE AND COMMISSION

Broker is entitled to commission as mutually agreed and specified in Exhibit A. Fees are due within two (2) banking days of each transaction close via EFT to SAAFI EXPRESS LLC designated account. Financial Institution: Mercury Bank / Citibank Texas, National Association.

3. NON-CIRCUMVENTION

Buyer and Seller, their agents and affiliates, irrevocably agree not to contact, deal with, or engage any entity introduced by Broker without Broker's express prior written consent. Breach renders the breaching party immediately liable for liquidated damages equal to the total fees that would have been earned on all circumvented transactions.

4. CONFIDENTIALITY

All parties agree to hold in strict confidence all information received in connection with this Agreement for five (5) years, including buyer/seller identities, pricing, volumes, logistics routes, contract terms, and banking information.

5. GOVERNING LAW

This Agreement is governed by the laws of the State of Texas. Disputes shall be resolved by binding arbitration in Harris County, Texas under AAA rules. Prevailing party recovers reasonable attorney fees and costs.
